CALL TO ORDER:

The Special Meeting of the Exmore Town Council was called to order at 7:00 pm by Mayor Moore. A quorum was established with one member absent.

The Invocation was given by Vice-Mayor Greer.

REQUEST FOR MOTION TO ENTER INTO CLOSED SESSION:

Mayor Moore announced that the purpose of the Special Meeting is to enter into closed session. Councilman Ward read the Motion as follows: "I move that the Council convene in closed session pursuant to Virginia §2.2-3711(A)(1) to discuss and consider the assignment, performance, demotion, disciplining, or resignation of an employee of the Town of Exmore.
